#### \*SAFETY\*

Just a reminder that safety is everyone's responsibility. Next time you come to the club, please rededicate yourself to safe shooting practices. These include, actions OPEN anytime the weapon is not being fired at a target or pattern board. Weapons pointed downrange before, during and after shooting - and pointed down and away from people near you. Please do not leave your weapon lying on the bench, or in the rack, with the action closed. While shooting skeet or trap, keep it open until you are on the station and preparing to shoot. Place only one or two shells in the gun at a time, depending on whether you are shooting singles or doubles. The wearing of side arms at NESA is prohibited except during competition or by a law enforcement officer.

# **Proposed NTSA By-law Amendment**

It is proposed that current NTSA By-laws be amended to include the following item within **ARTICLE II**, **Financial Obligations and Privileges**:

**II.9 Reporting of Income and Expenses** – All income and/or details of expense, resulting from an event, activity, competition, fund raising, fee, or any other source associated with the use of facilities, or properties owned by NTSA, shall be surrendered to the NTSA Treasurer, to be reported as NTSA business. Persons responsible for surrendering such funds and/or details of expense shall submit a written general accounting of how funds and/or expenses were realized to the Treasurer within 7 days.
