- Keep the muzzle pointed in a safe direction.
- Do not shoot any target placed directly on the ground.
- <u>Make sure that your rounds fired impact into the berm and do not skip off of the ground.</u>
- <u>All shooters on the rifle and pistol ranges should ensure that the rounds they fire pass through the black plastic backers and impact into the berms. Please place targets in the center of the plastic backer and avoid shooting the wood frames or the metal posts.</u>

The Horny Toad Handicap Buckle Shoot is scheduled for September 25<sup>th</sup>. Buckles will be awarded for 5 Yardage Group Winners and a Horny Toad hat pin will be given to all participants.

#### **August Board Meeting**

The September Board meeting was held on September 8<sup>th</sup>. The main agenda items were the land acquisition, safety issues, and voting on the precision rimfire rifle match.

The President gave an overview of the club activities and operating rules to 26 new members to the club and the Board voted them in.

The treasurer provided all members present with the monthly treasurer's report for the period ending August 2010. He advised that the club has approximately \$111,000 in the land fund, \$221.000 in regular CD's, and \$28,000 total in other accounts (money market, checking).

After the NTSA by-law process was completed, the club lost 13 members who failed to pay their dues by August 1<sup>st</sup> and whose memberships were revoked. Two members appealed their cases in person before the Board and were re-instated by Board vote.

Under old business, the Board discussed the land acquisition. Although specific details can not be published at this time,





significant progress has been made. However, negotiations are continuing and a comprehensive proposal for the membership needs to be developed to include a financial plan and a range development plan. The Board discussed the possibility of tentatively calling for a special meeting of the membership in early December to vote on the proposal. The Board re-iterated that the annual membership dues will increase \$100 with the land acquisition, but the value of each membership will increase substantially and the club will be able to offer sporting clays, five-stand, a 600-yard rifle range, and additional trap, skeet, pistol and rifle ranges.

As a follow up to the August meeting, the Board reviewed the NTSA safety rules in conjunction with the safety rules from the NRA, IBS, NBRSA, ATA, etc., and updated them as necessary. The updated rules were discussed and approved by the Board after some minor changes. The rules are effective immediately and will be placed on the website. They will also be used as the basis for the safety briefing as part of the orientation for new members.

With assistance from club member Merv Stelter, the VP prepared and presented an incident report form for adoption and implementation. The Board approved the incident report form, which will be used to process incidents at the club effective immediately.

During the August meeting, the Board discussed the proposal that the membership application include some statements regarding whether or not the new member is in possession of a current CHL and/or if a new member can legally own a firearm in Texas. The Board tabled the proposal until the October meeting when a draft membership application with proposed language will be presented.

The Board discussed Michael Plaxco's proposal to host a .22 precision rifle rimfire match to be held on the 3<sup>rd</sup> Sunday of each month beginning in January or February. The match would involve shooting paper targets at 50, 100, and 200 yards from the bench using a bipod and a rear rest, and 50 yards standing offhand. At the August Board meeting, Michael requested that the Board approve exclusive use of the rifle range for the match from 8 AM until 1 PM because squads will be using the 50, 100 and 200 yard firing points at the same time, and he expects the match to be very well attended. The Board voted to grant Michael's request for exclusive use of the range on a trail basis initially. This approval would convert automatically to a permanent basis after one quarter if no issues arise that could not be resolved. The match would not be held during the months of October and November to afford members every opportunity to sight in their rifles for hunting season. The match schedule will be placed on the calendar in the club house and the website, and will be coordinated with the bench rest matches.

### **Updated Range Safety Rules**

Please check the reference section on the NTSA website for the updated safety rules, or stop by the club for a copy. All members and their guests are requested to abide by the NTSA safety rules and to review them periodically.

### **Range Development Committee Volunteers Needed**

The Board needs volunteers to be a part of the Range Development Committee, who are willing to commit long term to actively working on the development of a proposal for the membership; and, if approved, for the implementation of the proposal. This is an enormous project that will involve a lot of work, but if implemented, will be a major benefit to the club for many years in the future. In May, the Board approved an increase in the membership cap from 600 to 700. In September, 26 new members joined the club, including two legacy members. The current voting membership is 691 not including the honorary or legacy members. The remaining members the club needs to reach the cap will be brought on in October.
